- 1** **The Gun Owner Harassment and Gun Registration Act (S. 374)**
SPONSOR: SEN. CHUCK SCHUMER (NY)
Bans the private sale or transfer of firearms between law-abiding gun owners, and according to Barack Obama's Justice Department, would need to be accompanied with universal gun registration in order to be "effective."
- 2** **The Gun Owner Licensing Act (H.R. 34)**
SPONSOR: REP. BOBBY RUSH (IL)
Forces gun owners to submit their most sensitive personal information to the federal government and obtain a special license before purchasing a firearm.
- 3** **The Handgun Owner Licensing and Registration Act (H.R. 117)**
SPONSOR: REP. RUSH HOLT (NJ)
Forces handgun owners to be registered with the federal government and obtain a special license from Barack Obama's anti-gun bureaucrats.
- 4** **The Magazine Ban (H.R. 138/ S. 33)**
SPONSOR: REP. CAROLYN MCCARTHY (NY)
Bans the possession, sale and transfer of any magazine capable of holding more than 10 rounds of ammunition.
- 5** **The Make Firearms Unaffordable Act (H.R. 661)**
SPONSOR: REP. BARBARA LEE (CA)
Imposes a stifling new excise tax on all "concealable" firearms, and directs the proceeds from the tax to fund a national gun "buyback" program.
- 6** **The Online Ammunition Sales Ban (H.R. 142/ S. 35)**
SPONSOR: REP. CAROLYN MCCARTHY (NY)
Bans the online sale of ammunition and forces state governments to keep a computer database containing the personal information of anyone who buys ammunition.
- 7** **The National Gun Buyback Act (H.R. 226)**
SPONSOR: REP. ROSA DELAURO (CT)
Abuses the tax code by offering special "credits" to lure gun owners into surrendering their firearms to the federal government.
- 8** **The Give Your Money to Eric Holder So He Can Buy Your Guns Act (H.R. 227)**
SPONSOR: REP. THEODORE DEUTCH (FL)
Authorizes Attorney General Eric Holder to funnel your taxpayer dollars to local law-enforcement agencies to conduct gun "buybacks" nationwide.
- 9** **The Taxpayer-Funded Gun Ban Propaganda Act (H.R. 321)**
SPONSOR: REP. CAROLYN MALONEY (NY)
Forces taxpayers to fund anti-gun propaganda studies produced by Barack Obama's gun ban bureaucrats.
- 10** **The Sue Gun Manufacturers Out of Existence Act (H.R. 332)**
SPONSOR: REP. ADAM SCHIFF (CA)
Gives trial lawyers the green light to bankrupt gun manufacturers by suing them when a firearm is misused by a criminal.
- 11** **The Semi-Automatic Firearms Ban (S. 150/H.R. 437)**
SPONSORS: SEN. DIANNE FEINSTEIN (CA) AND REP. CAROLYN MCCARTHY (NY)
Would ban tens of millions of semi-automatic rifles, shotguns and handguns.
- 12** **The Gun Show Harassment Act (H.R. 141)**
SPONSOR: REP. CAROLYN MCCARTHY (NY)
Forces gun show operators to submit their photographs and fingerprints to Attorney General Eric Holder. Also gives Holder the authority to enter the business of any gun show operator, without a warrant, and search and seize the operator's personal records, inventory, and files.
- 13** **The Tax Law-Abiding Gun Owners Through the Nose Act (H.R. 793)**
SPONSOR: REP. LINDA SANCHEZ (CA)
Another firearm tax, this bill forces gun owners to pay a crippling 10% sales tax on the purchase of any "concealable" firearm, and directs the proceeds from the tax to fund a national gun "buyback" program.
- 14** **The Ban on Small Revolvers (H.R. 965)**
SPONSOR: REP. LUIS GUTIERREZ (IL)
Bans affordably-priced revolvers and handguns that don't meet specific government-defined criteria, and effectively bars lower income Americans from purchasing a firearm for self-defense.
- 15** **The Make Gun Ownership Unaffordable Act (H.R. 1369)**
SPONSOR: REP. CAROLYN MALONEY (NY)
Requires law-abiding gun owners to purchase a newly created special liability insurance policy, or pay a \$10,000 fine to the federal government.
- 16** **The Ammunition Ban and Background Check Act (S. 174)**
SPONSOR: SEN. RICHARD BLUMENTHAL (CT)
Requires background checks for all ammunition purchases and bans certain types of commonly-used ammunition.
